



TERMS AND CONDITIONS

All matches in the Round Robin stage are best of 5 frames. Last 16 and Quarter Finals best of 9 frames. Semi Finals are best of 11 frames and the Final best of 17 (7/10) frames.

Matches from Saturday 21 October – Tuesday 24 October are played on a roll on/ roll off basis but will not start before the start times printed. Play will start at the allocated time each day with a short interval between matches. The evening session each day will not start before the time indicated on the format. Please note it is recommended that ticket holders arrive early for the best opportunity of a seat to their preferred match.

Table numbers for all matches up to and including the Quarter Finals will be determined the day before and published by the Tournament Director. The Order of Play for matches from 25-28 October will be published no later than Tuesday, 24 October.

Personal bookings can be made at the Aberdeen Box Office, Monday – Saturday 9.00am – 6.00pm, and on the day ticket purchases up to 15 minutes before the start of play at the AECC Box Office.
